Review activities - accreditation of postgraduate medical education programs of clinical education - in 2015, the ACGME accredited 9,747 residency programs in 31 major specialty areas and 112 other specialty training areas These programs are sponsored by approximately 692 institutions nationwide and another 12 internationally Accredited programs enroll over 123,000 residents each year Institutions submit statistical and narrative information on a regular basis through ACGME's Accreditation Data System and onsite reviews are conducted by ACGME staff periodically Accreditation decisions are made by 32 review committees, comprised of more than 450 volunteers who are leading specialists in each area, and based on previously developed core and specialty standards and established milestones

Field Activities - In 2015, The ACGME performed 1,324 accreditation site visits, and 155 clinical learning environment review (cler) site visits, with many visits being performed by a team of two or more site visitors Site visits included interviews with sponsoring institution leadership, program leadership, and trainees (residents and fellows), as well as reviews of submitted information Comprehensive reports were then prepared for use by the Review Committees

Educational Activities and Initiatives - The 2015 ACGME Annual Educational Conference was held in San Diego, California, with a record attendance of over 3,000 program directors, designated institutional officials, Coordinators, and other GME faculty and specialists, including the osteopathic community for the first time The three-and-a-half-day conference offered sessions on major initiatives of the ACGME, accreditation standards, and topics submitted by the GME community at large There was also a pre-conference, with over 1,800 attendees, focusing on osteopathic programs and the Single Accreditation System In addition to its annual conference, ACGME sponsored 23 workshops throughout the year to develop the competencies of faculty and administrators involved in accredited GME programs, 6 baldwin seminars on topics of general interest to the GME community, hosted 24 educational webinars and held a symposium on physician well-being
